It is not in dispute that in relation to the very same acquisition proceedings, arising out of the very same impugned award, in the case of similarly situated claimants, this Court vide judgment dated 13.12.2016, passed in RFA No.325 of 2010, titled as *NTPC Limited Versus Shri Amar Singh & another*, has already adjudicated the issues raised in the present appeals, upholding the award dated 30.07.2010, passed by the District Judge, in Reference Petition No.163 of

2003, titled as *Sh. Amar Singh Versus Land Acquisition Collector Kol-Dam Project, Sundernagar & another*, alongwith connected petitions, and disposing of the cross-objections, if any, filed by the claimants. Learned counsel further submit that the present appeals are thus squarely covered with the decision rendered in *Amar Singh* (supra).

2. As such, present appeals are also disposed of, making the directions in *Amar Singh* (supra) applicable *mutatis mutandi*, also to the claimants of the present appeals. Pending application(s), if any, also stand disposed of accordingly.
