### <u>ORDER</u>

The petitioner herein apprehending arrest in crime No.676 of 2017 of Cheranelloor Police Station for offences punishable under Section 143, 147, 341, 323, 343, 354, 427 r/w 149 IPC, seeks bail. She is arrayed as the first accused. Her husband is arrayed as the second accused. According to the prosecution, the petitioners along with few other the house of the trespassed into persons complainant on 08.06.2017 at 2pm, assaulted her, outraged her modesty and committed theft of a mobile phone worth Rs.10,000/- and a chain. Complaint was laid and in the course of investigation the second accused was arrested. Petitioner seeks bail.

2. According to the prosecution the mobile phone and chain also has not been recovered even now. Even

after the arrest of the second petitioner, no recovery could be effected. In the above circumstances, no purpose is served by the arrest and detention of the petitioner herein who is arrayed as the second petitioner. Having considered this and the nature of allegations, I am inclined to grant bail to the petitioner on the following conditions:

- (i) Petitioners shall appear before the investigation officer within ten days from today and shall undergo interrogation. Thereafter, if they are proposed to be arrested, they shall be released on bail on executing a bond for a sum of Rs.40,000/-(Rupees forty thousand only) each with two sureties for the like sum each.
- (ii) He shall appear before the investigating officer as and when called for.
- (iii) He shall not threaten, coerce or intimidate the defacto complainant and the witnesses, nor shall he interfere in the process of investigation.

(iv) He shall not get involved in any other identical offences.

Bail application is allowed as above.
