**ORDER**

Petitioner herein is the sole accused in Crime No.820 of 2017 of Town North Police Station for offences punishable under sections 452 and 354 of the Indian Penal Code and sections 7 and 8 of the Protection of Children from Sexual Offences Act.

2. It is alleged by the prosecution that the petitioner herein trespassed into the house of the victim on 07.08.2017 at 11.30 hours and sexually abused a 12 year old victim. He was arrested on 09.08.2017 and is in custody since then. He seeks bail.

3. It appears that the allegation against the petitioner herein is that with a sexual intent, petitioner herein approached the victim, kissed her and touched her body. This being the allegation, considering the detention of the petitioner herein and that the petitioner herein is not involved in any other crime, I am inclined to grant bail to the petitioner herein subject to the following conditions.

(i) Petitioner shall execute a bond for a sum of Rs.40,000/- (Rupees forty thousand only) with two sureties for the like sum each to the satisfaction of the jurisdictional Court.

(ii) He shall appear before the Investigating Officer on all Fridays between 9 a.m. and 10 a.m. for a period of two months from the date of his release.

(iii) He shall not threaten, coerce or intimidate the de facto complainant and the witnesses nor shall he interfere in the process of investigation.

(iv) Except for the compliance of the above condition or for appearance in a Court of law where his appearance is mandatorily required, he shall not enter the limits of Town North Police Station for a period of three months from the date of his release. In case of extreme emergency, he can enter the limits with the express permission in writing of the jurisdictional court.

(v) He shall not get involved in any other identical offences.

The bail application is allowed as above.
