JUDGMENT

The petitioner is a stage carriage operator in respect of vehicle No. KL-35-D-7344. He has submitted an application seeking renewal of the permit which was adjourned as per Ext.P2 for want of necessary concurrence from the sister RTAs. The subject issue with respect to securing concurrence from the sister concerns for renewal of the permit was considered by this Court in W.P.(C) No. 1786/2017, rendered a judgment dated 17.03.2017, whereby, it is held that the concurrence from the sister RTAs are not required for renewal. According to the learned counsel for the petitioner, RTA meeting is scheduled to 4.5.2017 and appropriate directions may be issued in terms of the judgment rendered by this Court evident from Ext.P3.

2. Having heard the learned counsel for the petitioner and the learned Government Pleader, there will be
