# JUDGMENT

The petitioner is a partnership firm, engaged in the manufacturing and sales of studded gold ornaments and conducting business in the name and and style 'Jwala Diamonds & Jewellers', at South Bazar, Thrissur. The petitioner was issued with Ext.P6 notice apparently under Section 47(2) of the KVAT Act. The petitioner has submitted objection to the same evident from Ext.P7. According to the petitioner, Ext.P6 notice issued is not in accordance with law and therefore, the entire action initiated by the respondents suffers from the vise of arbitrariness and interference of this Court at this stage of the proceedings is required under Article 226 of the Constitution of India. It is thus seeking appropriate directions, this writ petition is filed.

2. Heard the learned counsel for the petitioner and the learned senior Government Pleader. Anyhow, even

if the petitioner has a case that the subject issue under Ext.P6 is without jurisdiction by the statutory authority, the same is a subject matter which can be considered by the said authority itself having raised by the petitioner in Ext.P7 objection. Therefore, there will be a direction to attain finality to Ext.P6 proceedings initiated, within two months from the date of receipt of a copy of this judgment. In the meanwhile, the goods detained as per Ext.P6 shall be released to the petitioner on the petitioner executing a bank guarantee for 50% of the demand contained in Ext.P6 and executes a simple bond for the balance 50%.

The writ petition is disposed of accordingly.
