**JUDGMENT**

**P.N.Ravindran, J.**

Ext.P7 order passed by the Admission Supervisory Committee for Professional Colleges in Kerala on 1.12.2016 is under challenge in this writ petition filed under Article 226 of the Constitution of India. It is not in dispute that the petitioner college did not apply to the All India Council for Technical Education for approval to admit students under the NRI quota. The requisite fee also was not paid. An inspection of the College for the said purpose was also not carried out.

2. A Division Bench of this court has in identical circumstances declined to interfere with similar orders passed by the Admission Supervisory Committee whereby the names of the students who were admitted in the NRI quota were directed to be removed. The issue raised is in our opinion squarely covered against the petitioner by the decision of the Division Bench in W.P.(C).No.40711 of 2016.

The writ petition fails and is accordingly dismissed. A copy of the judgment in W.P.(C).No.40711 of 2016 shall be appended to this judgment.
