**Judgment**

The petitioner is aggrieved with the seizure of the vehicle owned by the petitioner bearing Registration No.KL-14A-4609. The 1<sup>st</sup> respondent is said to have intercepted the vehicle and seized it.

2. The learned Government Pleader has produced the report of the Sub Inspector of Police, dated 25.05.2017 along with memo dated 29.05.2017; which speaks of detention and seizure of the vehicle on 24.04.2017, for reason of transporting laterite stone without any pass or documents. In such circumstance, the Sub Inspector of Police, under the provisions of the Kerala Minerals (Prevention of Illegal Mining, Storage and Transportation Rules, 2015, shall produce the

vehicle before the jurisdictional Magistrate, within a period of one week from the date of receipt of a certified copy of this judgment.

The writ petition would stand disposed of.
