JUDGMENT

Antony Dominic, J.

Petitioner is the managing partner of Maharaja Steels at Thamarassery in Kozhikode district. The loading and unloading work in his establishment was obstructed by the respondent union claiming that it being a scheme covered area they alone are entitled to do the work. The case of the petitioner was that he has his own workers and that an application made by him for registration under Rule 26A of the Kerala Head Load Workers Rules was pending since 12.6.2017.

2. Today, it is submitted by the petitioner and confirmed by the learned Government Pleader that orders have been passed on the application made by him for registration and registration has been granted. Now that his workers are registered under Rule 26A, there cannot any obstruction to the work utilising their services.

: 2 :

3. In such circumstances, it is ordered that in the event any obstruction is caused by the party respondents herein to the loading and unloading work of the petitioner's establishment employing its registered employees, it will be open to him to report the matter to the third respondent who thereupon will take action for removal of such obstruction.
