Shaffique, J.

Petitioner had approached this Court alleging that he had lawfully married the detenue.

2. We have interacted with the detenue, who was produced before this Court. On our interaction, she stated that she is voluntarily residing with her parents and Ext.P1, the alleged marriage certificate, is only a mistake.

3. Perusal of Ext.P1 would show that it has no legal validity as the parties belong to two different communities. Under such circumstances, we do not think that any further direction is required in the matter.

Writ petition is dismissed.
