In view of the submissions made by the learned counsel for the petitioner, there shall be a direction to the first respondent to consider the petitioner's representations dated 01.11.2017 and 24.12.2017 and pass appropriate orders on merits and in accordance with law, within a period of two weeks from the date of receipt of a copy of this Order.
- 7. Accordingly, this Writ Petition is disposed of with the above direction. No costs. Consequently, connected miscellaneous petitions are closed.
