Learned counsel for the petitioners, at the very outset, submits that the controversy raised, in the instant writ application, stands resolved in view of the adjudication made by a Division Bench of this Court in the case of State of Rajasthan Versus Banne Khan: S.A.W. Number 763/2011, decided on 2nd August, 2011.

It is further contended that for the present; the petitioners would be satisfied, if the State-respondents are directed to decide the representation of the petitioners in the backdrop of the adjudication in the case of Banne Khan (supra), within a time frame, which they are ready and willing to address within two weeks hereinafter.

In view of the limited prayer addressed; the instant writ proceedings are closed with a direction to the petitioners to

address a comprehensive representation enclosing a copy of the order in the case of Banne Khan (supra).

In case, a representation is so addressed within the aforesaid period, the State-respondents are directed to consider and decide the same by a reasoned and speaking order as expeditiously as possible in accordance with law. However, in no case later than four weeks from the date of receipt of the representation along with a certified copy of this order.

With the observations and directions, as indicated above, the writ application stands disposed off.
