The present misc. bail application under Section 439 Cr.P.C. is preferred by the Accused/Petitioners Deepak Choursiya, Vikas Choursiya, Pradeep Kumar and Alok Kumar in the matter of FIR No. 99/2017 registered at Police Station Ashok

Nagar, Jaipur Metropolitan for offences punishable under Sections 419, 420 IPC & 66C, 66D I.T..

Learned counsel for the petitioner submits that police has already recovered Rs. 2,22,000/- cash, ATM and cheque book etc. Petitioners are in custody since 17.04.2017. The alleged offence is triable by First Class Magistrate. Their further custody is not warranted in the matter, therefore, they may be released on bail.

Learned Public Prosecutor Mr. Aladeen Khan opposed the Bail Application.

I have considered the submissions made at Bar.

On consideration of submissions made on behalf of the respective parties and the material made available for my perusal, therefore, without expressing any final opinion on the merit and de-merit of the case and considering the overall facts and circumstances of the case, I am inclined to grant benefit of bail to the accused-petitioners Deepak Choursiya, Vikas Choursiya, Pradeep Kumar and Alok Kumar .

Consequently, the bail application filed under Section 439 Cr.P.C. is allowed.

Therefore, it is ordered that the accused-petitioners Deepak Choursiya s/o Sh. Dati Choursiya, Vikas Choursiya s/o Sh. Dati Choursiya, Pradeep Kumar s/o Lt. Shri Rajnandan Prasad and Alok Kumar s/o Shri Chandrabhusan Choursiya in FIR No. 99/2017 registered at Police Station Ashok Nagar, Jaipur

Metropolitan shall be released on bail; provided each furnishes a personal bond of Rs. 2,00,000/- and two surety bonds of Rs. 1,00,000/- each to the satisfaction of the learned trial court with the stipulation to appear before the Trial Court on all dates of hearing and as and when called upon to do so.
