1. The petitioners have preferred this criminal misc.petition under Section 482 Cr.P.C. for issuance of necessary

directions to the official respondents to provide adequate security and protection to the petitioners on the ground that they are facing grave threat of life and liberty at the hands of their respondents and relatives, in view of solemnization of their marriage with each other on 30.08.2017.

2. After hearing the learned counsel for the parties and on an overall consideration of the facts and circumstances of the case, this Court deems it proper to direct the petitioners to appear before the Superintendent of Police, District Sri Ganganagar, who shall hear the grievance of the petitioners, and if necessitated, provide adequate security and protection to the petitioners.

3. Consequently, the present misc.petition stands disposed of. The stay application also stands disposed of.
