**ORAL ORDER**

3 28-02-2018 Heard the learned counsel for the petitioners and the learned A.P.P. for the State.

This is an application for grant of anticipatory bail in connection with Kako P.S. Case No. 76 of 2017 registered for the offence punishable under Sections 147, 148, 353 and 504 of the Indian Penal Code.

The petitioners herein are said to be implicated in the present case at the instance of the Chaukidar of the village and are said to be part of the mob which had obstructed the way and had



tried to overawe the police force.

The learned counsel for the petitioners submits that the petitioners herein are poor people having no concern with such type of the occurrence and the Chaukidar with vengeance has falsely given their names and made them accused in the present case. It is further submitted that similarly situated co-accused person has been granted bail by this Court vide order dated 17.02.2018 passed in Criminal Misc. No. 7987 of 2018. The petitioners are said to be having a clean antecedent.

Having regard to the facts and circumstances of the case, I deem it fit and proper to admit the petitioners herein to the privilege of anticipatory bail, in the event of their arrest or surrender before the court below within a period of six weeks from the date of receipt/production of a copy of this order on furnishing bail bond of Rs. 10,000/- (rupees ten thousand) each with two sureties of the like amount each to the satisfaction of learned C.J.M., Jehanabad in connection with Kako P.S. Case No. 76 of 2017 subject to the conditions as laid down under Section 438(2) of the Code of Criminal Procedure.
