ORDER

Heard Mr. U.J. Saikia, learned counsel for the petitioner. Also heard Mr. P.K.R. Choudhury, learned counsel for the respondent No.5 as well as Mr. N. Sarma, learned standing counsel for the Secondary Education Department.

By this writ petition, the order dated 16.03.2012 of the Director of Secondary Education, Assam has been assailed. By the said order, the respondent No.5 was promoted to the post of Headmaster of Public High School in the Dibrugarh district. The petitioner raises a claim that otherwise, the petitioner is senior to the respondent No.5 and therefore, the order promoting the respondent No.5 is vitiated. On the other hand, the respondent takes a stand that the petitioner does not have the BT and B.E.d qualification and therefore, he is ineligible for promotion for the post of Headmaster.

It is stated that the requirement of BT and B.E.d as an essential qualification has been settled by the Division Bench by its order 31.07.2017 in WP(C) No. 1526/2012. As the issue has been settled that BT and B.E.d is an essential qualification and as the petitioner admittedly does not have the required qualification, therefore, the claim of the petitioner that he was entitled to have been promoted to the post of Headmaster on the basis of being the senior most teacher, is unacceptable.

In view of the above, writ petition stands dismissed.

Interim order, if any, passed earlier stands vacated.
