'D' mark was inserted against the name of the petitioner in the voters' list of 1997 suspecting him to be a doubtful voter.

Mr. A.I. Ali, learned standing counsel, Election Commission of India and Mr. J. Payeng, learned special standing counsel, Foreigners Tribunal, have submitted after obtaining instructions that no reference is pending against the petitioner before the Foreigners Tribunal.

By this writ petition, the petitioner has prayed for a direction to the respondents, either to withdraw or delete the 'D' mark against the petitioner and/or to make a reference to the appropriate Foreigners Tribunal for enabling the petitioner to establish that he is a citizen of India.

Mr. Das submits that a direction may be issued to the Superintendent of Police (B), Darrang, to make a reference to the appropriate Foreigners Tribunal.

In view of the above submission, the writ petition is disposed of directing the Superintendent of Police (B), Darrang to make a reference to the appropriate Foreigners Tribunal within a period of 1(one) month from the date of receipt of the certified copy of this order. Thereafter, the learned Tribunal will dispose of the case as expeditiously as possible.
