**ORDER**

**Date : 21-12-2018**

Heard Mr. B Deka, learned counsel for the petitioners and Ms. A Verma, learned counsel appearing for the State Coordinator, NRC, Assam.

Petitioners are aggrieved by the action of NRC authorities in putting their names on hold in the final draft NRC.

It is contended that parents of the petitioners were declared as foreigners belonging to the 1966 to 1971 stream by Foreigners Tribunal, Nagaon. However, that order was set aside by this Court when it was put to challenge.

On a query by the Court, Mr. Deka, learned counsel for the petitioners submits that petitioners have lodged claim before the NRC authorities that their names, as included in the draft NRC, should be maintained and the put on hold order should be revoked.

Ms. Verma, learned Standing Counsel submits that last date for submission of claims and objection is 31.12.2018. Thereafter date(s) will be notified for hearing of claims and objections. Petitioners would also be informed by the NRC authorities for hearing of their claim.

In view of above, Court is of the view that the writ petition filed is premature and no interference is called for at this stage. That apart, when the Supreme Court is monitoring the

matter relating to updation of NRC, interference by the High Court may not be justified.

Subject to the observation made above, writ petition is dismissed.
