Apprehending their arrest, the petitioners have moved this Court for grant of privilege of anticipatory bail in connection with Chas P.S. Case No. 256 of 2017 (G.R. No. 1308 of 2017) registered under sections 448/323/354/379/386/406/452 of the Indian Penal Code.

Heard the learned counsel for the petitioners and the learned Addl. P.P. for the State.

Learned counsel for the petitioners submits that the allegation against the petitioner is that the petitioners entered into the house of the informant and looted cash of Rs.27,000/- and Jewelry of Rs.1,50,000/- and also outraged the modesty of the daughter-in-law of the informant and also committed criminal breach of trust and demanded ransom. Learned counsel for the petitioners further submits that there is a long standing dispute between the parties and from the sides of the petitioners O.S. Case No.65 of 2017 has been filed in the court of Civil Judge, Senior Division-1, Bokaro. It is further submitted that the petitioners are ready and willing to deposit Rs.5000/- each as victim compensation and also undertakes that they will not go over or near the place of occurrence house of the informant during the pendency of this case. Hence, it is submitted that the petitioners be given the privilege of anticipatory bail.

Learned Addl. P.P. opposes the prayer for grant of anticipatory bail.

Considering the submissions of counsels and the aforesaid facts and circumstances of the case, I am inclined to grant privileges of anticipatory bail to the petitioners. Hence, in the event of their arrest or surrender within a period of four weeks from the date of this order, they shall be released on bail on depositing demand draft of Rs.5000/- each drawn in favour of the informant-Debu Dutta and on furnishing bail bond of Rs. 10,000/- (Ten thousand) each with two sureties of the like amount each to the satisfaction of learned Chief Judicial Magistrate, Bokaro in connection with Chas P.S. Case No. 256 of 2017 (G.R. No. 1308 of 2017) with the condition that they will not go over or near the place of occurrence house of the informant during the pendency of this case and subject to the conditions as laid down under Section 438(2) of the Code of Criminal Procedure.

In case, the petitioners deposit the demand draft, the learned court below is directed to issue notice to the informant-Debu Dutta and release the same in his favour forthwith.
