Learned A.P.P. appearing for the State opposes the prayer for bail of the petitioners.

Petitioners are accused for allegedly committing the offence punishable under Sections 356, 382, 411, 413 & 34 of the Indian Penal Code, in connection with Sadar (Bara Bazar) Police Station Case No.328 of 2018 corresponding to G.R. No.1851 of 2018, pending in the Court of learned Chief Judicial Magistrate, Hazaribagh.

This is a case of chain snatching. Petitioners were arrested when they were fleeing away after snatching the golden chain.

Learned counsel for the petitioners submit that chargesheet has already been submitted and petitioners have remained in custody since 22.06.2018.

Considering the period of custody and the fact that chargesheet has already been submitted in this case, I am inclined to grant bail to the petitioners. Accordingly, petitioners, namely, Md. Akbar and Raja Babu Ansari @ Bade Mian (in B.A. No.7434 of 2018) and Dinanath Sonar (in B.A. No.7530 of 2018), are directed to be released on bail on furnishing bail bonds of Rs.10,000/- (Rupees Ten Thousand) each with two sureties of the like amount each to the satisfaction of the learned Chief Judicial Magistrate, Hazaribagh in connection with Sadar (Bara Bazar) Police Station Case No.328 of 2018 corresponding to G.R. No.1851 of 2018, with a condition that the petitioners should appear and mark their attendance before the Officer-in-Charge, Sadar (Bara Bazar) Police, Station, Hazaribagh once every fortnight and in the event the petitioner(s) fail to appear before the Officer-in-Charge, Sadar (Bara Bazar) Police

Station, Hazaribagh in any particular fortnight, bail bonds furnished by the petitioner(s) shall stand cancelled and the Officer-in-Charge, Sadar (Bara Bazar) Police Station, Hazaribagh will take all steps for re-arrest of the petitioner(s).
