Mr. Keatn Parikh, learned Standing Counsel appears for the respondent authorities upon service of advance copy of each of the petition. Accordingly, he is permitted to file his appearance in the petitions.

- 2 Learned counsel for the petitioners, after arguing the matters for some time, seeks permission to withdraw all these petitions, with approach the concerned to respondent authorities adjudicate to the grievances especially with regard to Liberalised Active Retirement Scheme for Guaranteed Employment for Safety Staff [LARGESS] with a prayer to set aside the direction contained in the impugned orders of awarding costs of Rs.2 lakhs upon the petitioners in each of the petition.
- Having heard learned counsels for the parties and considering the challenge to the judgment dated 22.02.2018 rendered in a group of original applications in the context of challenge in its entirety before the Central Administrative Tribunal of termination of LARGESS in view of

direction given by the Apex Court in SLP [C] No.508 of 2018 dated 08.01.2018, and persuasion of legitimate scheme by the applicants before the Central Administrative Tribunal by raising various contentions of law as well as on facts, we are of the view that costs ought not have been imposed upon the petitioners.

In view of the above, all these petitions stand disposed of as withdrawn. The costs of Rs.2 lakhs imposed by the Tribunal upon each of the petitioner in the impugned order, is hereby set aside.

We make it clear that permission for withdrawal is granted in all these writ petitions for a limited purpose to ventilate legitimate grievance in accordance with law about communication dated 26.09.2018 addressed to all General Managers, All Indian Railways.
