- 2. The learned Advocates for the parties have tendered Consent Terms dated 28th April, 2018. They submit that the Consent Terms be taken on record and the above Arbitration Petition be disposed of in terms of the Consent Terms. The Consent Terms are taken on record and marked 'X' for identification. The Consent Terms are signed by the Petitioner, Respondent No.1, constituted attorney of Respondent No.2, Respondent No.4 for self and as constituted attorney of Respondent No.3, Respondent Nos.6 to 10. The Advocates for the parties have also signed the Consent Terms. All the signatories to the Consent Terms, are present in Chambers. They have stated the Consent Terms are signed by them of their free will and volition and there is no fraud, force and collusion involved. The undertakings recorded in the Consent Terms are accepted. - 7. The Advocates for Respondent No.1 shall pay Rs.15,000/- as costs, charges and expenses to the Court Officer who had visited Pune as directed by this Court by its order dated 13th April, 2018.
