MFA No.4763/2015 is filed by one Basavaraju-owner of the vehicle and **MFA No.8236/2015** is filed by the claimants.

2. Both the learned counsels submit that since the dispute has been settled out of the Court by a compromise,

both the appeals have become infructuous and the same may be dismissed as not pressed.

3. A Joint Memo dated **31.10.2018** is filed today and the same is taken on record and as per the compromise a sum of **Rs.10,00,000/-** stands paid to the claimants and the learned counsel for the appellant-owner of the vehicle has prayed that the statutory deposit of **Rs.25,000/-** in **MFA No.4763/2015** by **DD No.014801** drawn on **Nyayamitra Bank, High Court of Karnataka** dated **29.09.2015** for maintaining his appeal may be refunded back to the Respondent-owner of the vehicle.

4. The prayer seems to be genuine.

5. Therefore, ordered accordingly. The Registrar may take steps to refund that amount to the appellant-owner of the vehicle.
