Heard.

2. First Respondent is petitioner's daughter-in-
law.

3. By an order dated 23.10.2017, the Family
Court, Kolar, in Crl.Mis.(FC) No.55/2017 has awarded
an interim maintenance of Rs.10,000/- per month to be
paid by the petitioner to the Respondents.

4. It is submitted that the petitioner did not pay the said amount to the Respondents. Hence, the Respondents initiated execution proceedings in Ex.No.2/2018. The petitioner has now filed this petition seeking transfer of the Execution case from Kolar to Bengaluru.

5. Learned advocate for the Respondents has no objection for transfer of the said case from Kolar to Bengaluru, subject to payment of travel and incidental costs by the petitioner to attend hearings in the Court at Bengaluru.

6. Keeping in view of the facts and circumstances of the case, the petition is ***allowed***. The case in Ex.No.2/2018 pending on the file of the Principal Family Court, Kolar, is transferred to the Court of Principal Family Court, Bangalore, subject to the petitioner paying cost of Rs.1,000/- per hearing. The said amount shall be paid in advance to the 1st

Respondent by transferring the amount to her Bank
Account in advance.
