THIS MISCELLANEOUS FIRST APPEAL IS FILED UNDER SECTION 173(1) OF MV ACT AGAINST THE JUDGMENT AND AWARD DATED 28.08.2014 PASSED IN MVC NO. 2079/2012 ON THE FILE OF THE VIII ADDITIONAL SMALL CAUSES JUDGE & XXXIII ACMM, MEMBER – MACT, BENGALURU, PARTLY ALLOWING THE CLAIM PETITION FOR COMPENSATION AND SEEKING ENHANCEMENT OF COMPENSATION.

# JUDGMENT

This appeal by the claimant challenges the judgment and award dated 28.08.2018 made by M.A.C.T. Bengaluru (SCCH-5) allowing M.V.C.No.2079/2012, whereby a compensation of Rs.1,10,000/- with interest at the rate of 8% p.a. has been awarded. The challenge is on the ground of inadequacy of compensation.

- 2. The matter was heard at some length. Thereafter with the intervention of the Court, the parties have amicably settled the *lis*, whereunder, an additional sum of Rs.50,000/- free of interest has been awarded in addition to what has been awarded by the M.A.C.T.
- 3. In view of the above, this appeal partly succeeds; the impugned judgment and award are modified enhancing the compensation from Rs.1,10,000/- to Rs.1,60,000/-. However, the additional compensation of Rs.50,000/- now awarded, shall not carry any interest.

The insurer to make good the differential amount of compensation forthwith.
