- 2. On 03.07.2018, this Court, while issuing notice to the respondents, impleaded the alleged encroacher as party respondent No. 7 and requested Mr. Tara Singh Chauhan, learned Counsel, who was present in the Court, to assist as Amicus Curiae.
- 3. Today, when the case was taken up, learned Amicus Curiae has filed status report and one affidavit also stands filed on behalf of respondent No. 3, which are taken on record. A perusal of the same demonstrates that the contents of the letter petition were found to be correct.
- 4. At this stage, Mr. Suneet Goel, learned Counsel, under instructions, from Sh. Amin Mohammad, son Sh. Abdul Rashid, r/o Panthaghati, Shimla (respondent No. 7), states that respondent No. 7 has no objection to (a) the construction of the path by the Municipal Corporation; (b) reinforcing of the foundation by any one of the neighbours; (c) cordoning of the area by the Municipal Corporation, if so required and desired, subject to availability of the budget; and (d) laying of water pipes, if so required and desired. Statement accepted and taken on record.
- 5. Learned Amicus Curiae as also learned Additional Advocate General have expressed their satisfaction to the

statement so given on behalf of respondent No. 7 and

submitted that the petition can be closed at this stage.

Ordered accordingly.
