This Court took suo motu cognizance of a letter petition, addressed to it by the residents of Village Nyori, Post Office Gohar, Tehsil Chachiot (Gohar), District Mandi, who had highlighted the issue of alleged encroachment over school ground by respondent No. 6.

- 2. On 20.7.2018, while issuing notice, this Court directed respondent No. 4, i.e. SDM, Chachiot (Gohar), District Mandi to visit the spot forthwith and submit his report. This Court had also requested Mr. Harsh Kalta, learned counsel, who was present in Court to assist in this matter as Amicus Curiae.
- 3. Pursuant to the order of this Court, status report has been filed by respondent No. 4, perusal of which demonstrates that land in issue is in fact owned by respondent No. 6 and is in his possession, except land measuring 0-

9-14 bigha, which though is owned by respondent No. 6, but is in the

possession of that school. Thus, it stands mentioned in the status report that

respondent No. 6 has not encroached upon the Government land, but on the

contrary, certain portion of the land owned by respondent No. 6, is in

possession of the school.

4. Having perused the status report and having heard the learned

Amicus Curiae as well as learned Additional Advocate General, we close this

petition with the observations that every endeavour shall be made by

respondent No. 4 to ensure that an adequate play ground is made available for

the children of the Government Middle School, Deleg at Tikri.

5. Before parting, we wish to place on record our appreciations for

the efforts put in by the learned Amicus Curiae, who on the instructions of this

Court, contacted letter petitioner and obtained necessary feedback.

6. Registry is directed to send a copy of this judgment to the

Deputy Commissioner, Mandi and to the SDM, Chachiot (Gohar), District

Mandi for necessary action as well as to the letter petitioner to enable him to

take follow-up action with the concerned authorities.

Petition stands disposed of accordingly.
