Aggrieved by the delay in disposing Ext.P6 application to implead respondent Nos.12 to 14 in Ext.P3 proceedings and Ext.P8 temporary injunction application in Ext.P7 proceedings, the petitioner approached this Court invoking writ jurisdiction under Article 227 of the Constitution of India, seeking a direction to dispose Exts.P6 and P8, within a time frame.
