JUDGMENT

petitioner, who The is a Senior filed this Superintendent has writ petition challenging his transfer as well the as order rejecting his appeal in Ext.P7 order by the Grievance Redressal Committee.

- 2. It is stated that petitioner is due to retire from service on 31.07.2019. It is also stated that he joined as Senior Superintendent on promotion and posted at Pathanamthitta only 29.07.2015, where he is entitled to continue for a period of three years.
- 3. Petitioner was transferred from Pathanamthitta to Unnikulam Sub Station at Kozhikode.

According to him, he has been subjected to transfer before completing his normal tenure and without giving him the benefit of a posting near home station on account of the impending retirement in 2019, only because he is an office bearer of an employees' organisation rival to the ruling party.

Petitioner had raised these contentions in 4. which was considered the appeal by the committee on direction from this Court. The appeal committee found that, out of the total services of 23 years and 6 months, he worked in his domicile station Kollam for 18 years and the rest of period he worked in Pathanamthitta except for the period of 1 year and 4 months at Malappuram. It is pointed out that there shortage of officers in northern districts of Kerala and petitioner was found to have the minimum index of 32159 and he was not found eligible to be retained at Pathanamthitta. It is also stated that there are 23 officers who declared their domicile as

Pathanamthitta whereas the number of posts available in Pathanamthitta is only 21. Therefore, petitioner who is having the least service index was transferred.

- 5. Apart from the vague statement that petitioner belongs to a rival organisation, petitioner has not alleged any malafides behind the transfer with the support of any materials. It is relevant to note that petitioner could continue major portion of service in his domicile station itself despite being an office bearer of the said service organisation.
- 6. In the above circumstances, the order of transfer Ext.P7 cannot be said to be illegal warranting interference of this Court under Article 226 of the Constitution of India. It is for the 1st respondent to decide where the employees should be posted.
- 7. The learned Standing Counsel points out that the process for the next General Transfer for the year 2018-19 has already started. Petitioner is free to

submit his application and claim whatever benefits are available to him.

With this observation, this writ petition is dismissed.
