JUDGMENT

The petitioner's son passed the Secondary School Examination of the Central Board of Secondary Education (CBSE) in the year 2017. In the certificate of his son, the petitioner's name was shown as 'Binitha Rajeev'. Petitioner wants to change it as 'Binitha V.S'. Petitioner's request has been rejected by Ext.P3. Challenging this order, the petitioner approached this Court.

- 2. Heard the learned counsel for the petitioner and the learned Standing Counsel.
- 3. There cannot be any difficulty in correcting the mother's name in the certificate, as declared by this Court in the series of judgments. In the light of the various judgments of this Court, the following directions are issued:

- i. The School authority/ $4^{\rm th}$ respondent shall correct the name and forward the school records to the CBSE within a period of one month.
- ii. Thereafter, the CBSE shall act upon such records and cause correction of the CBSE certificate within a further period of two months.
- Iii. Considering the delay involved in the matter, the petitioner shall pay a sum of Rs.3,000/- (Rupees three thousand only) to the CBSE.

The writ petition is disposed of as above.
