JUDGMENT

The petitioner impugnes the execution proceedings initiated by the 2nd respondent Consumer Disputes Redressal Forum, Palakkad to enforce Ext.P1 order issued by it. According to him, he has already filed an appeal before the Kerala State Consumer Disputes Redressal Commission and that it is posted to 11.5.2018.

- 2. The petitioner's greivance appears to be that pending the appeal before the Commission, the CDRF, Palakkad is likely to issue warrant against him tomorrow, when the matter is next posted before it. I am afraid that these submissions cannot persuade this Court to excercise jurisdiction against the execution proceedings because, I am of the view that the petitioner will have to invoke appropriate remedy before the State Commission.
- 3. In any event of the matter, the petitioner's apprehension is only conjectural since no warrant,

admittedly has been issued by the CDRF.

In such view of the matter, this writ petition is dismissed, however reserving liberty to the petitioner to approach the Commission appropriately, if a warrant of arrest is issued against him by the CDRF as apprehended by him.
