J U D G M E N T

The petitioners challenge the action taken by the Canara Bank under the Revenue Recovery Act to recover certain amounts due from him under a loan availed of by him from the Bank.

2. The learned Standing counsel appearing for the Canara Bank submits that the total outstanding dues in the loan as on today is Rs.4,63,783/- and he fairly concedes that the petitioner can be allowed to repay the whole amounts with future interest in 10 equal monthly installments.

3. I find the submission of the learned Standing Counsel to be very fair and therefore, order this writ petition granting liberty to the petitioner to pay off the total outstanding amounts as aforementioned along with future interest in 10 monthly installments commencing from 15.05.2018. It goes without saying that if there is any default in making the

payment as directed above, the benefit granted under this judgment would stand vacated and the Bank will be at liberty to recover the entire liability from the petitioner by continuing with the proceedings from the stage it is on this date.

The writ petition is ordered accordingly.
