JUDGMENT

The petitioner has filed this writ petition aggrieved by the recovery action initiated by the Kerala State Financial Enterprises Ltd (KSFE) to recover certain amounts that are allegedly due from him under a loan transaction he had with KSFE.

2. When this matter was taken up today, the learned counsel for the petitioner confined his submissions to a request to the KSFE to permit him to pay the entire amount outstanding in easy instalments. The learned Standing Counsel appearing for the KSFE submitted that the total overdue, as on 27.04.2018, is Rs.5,49,516/- (Rupees five lakhs forty nine thousand five hundred and sixteen only) and he graciously submitted that this can be allowed to be paid by the petitioner along with future interest in ten monthly equal instalments commencing from 15th of May, 2018.

Taking note of the submission made by the learned counsel on either side, I dispose of this writ petition permitting the petitioner to pay the amount of Rs.5,49,516/-along with interest from 27.04.2018, in ten equal monthly instalments commencing from the 15th of May, 2018. I clarify that, if the petitioner commits any default in payment of the instalments as directed herein, the benefit of the judgment shall stand vacated and the KSFE will be at liberty to initiate action to recover the entire amount from him as per law.
