JUDGMENT

1. Petitioner, who was retired as a driver from the Palakkad Depot, has approached this Court seeking a direction to the respondents to disburse the amounts of DCRG, regular pension, commuted value of pension, Provident Fund Closure, Terminal Leave Surrender value and Staff Welfare Fund amount due to him.
2. Heard the learned counsel for the petitioner and also the learned Standing Counsel appearing for the respondents.
3. The learned Standing Counsel for the KSRTC would submit that earnest efforts have been taken to disburse the pensionary benefits payable to the petitioner.
4. In such circumstances, this writ petition is disposed of by directing the respondents to disburse the admissible pension and other pensionary benefits payable to the petitioner, as

expeditiously as possible, at any rate within a period of six weeks from the date of receipt of a copy of this judgment, if there are no other legal impediments standing in the way.
