JUDGMENT

The petitioner has been denied affiliation for the academic year 2018–2019 to start various programmes in Engineering on account of the fact that the college has no power supply and some of the students raised a complaint regarding refund of fees. The Appeal Committee rejected it on 15.5.2018. This was affirming a report of the Expert Visit Committee pointing out certain deficiencies on 8.5.2018. It is to be noted that the petitioner was conducting engineering programmes from 2003 onwards and on account of certain deficiencies, AICTE withdrawn the approval and thereafter, it was restored.

2. The petitioner submits that they were using generator and they were taking steps to restore the electric supply as well. Subsequently, it was restored.

- 3. The learned Standing Counsel refers to the judgment of the Hon'ble Supreme Court in Parshvanath Charitable Trust and Others v. All India Council for Technical Education [(2003) 3 SCC 385] and submits that the University has to follow strictly the time schedule fixed therein for granting approval. It is to be noted that the University has erroneously rejected the application on the last date. Therefore, that will not preclude from this Court from interfering with such decision and restore the rights of the petitioner as stood as on the cut of date.
- 4. This Court is of the view that the University could not have refused affiliation on this ground especially when AICTE has granted approval. The second objection was also not relevant without specifically identifying the complaint of the students in regard to the refund of fees. Anyhow, those could not have any bearing on granting

affiliation. Therefore, Ext.P7 order is set aside. The University is directed to grant affiliation to the petitioner within one week from the date of receipt of a copy of this judgment. If the petitioner produces consent or order of affiliation, the Commissioner of Entrance Examination shall include the petitioner for further allotment.

The writ petition is disposed of as above.
