THIS WRIT PETITION (CIVIL) HAVING COME UP FOR ADMISSION ON 31.08.2018, THE COURT ON THE SAME DAY DELIVERED THE FOLLOWING:

#### JUDGMENT

Heard the learned counsel for the petitioners and the learned counsel for the respondent Bank, besides perusing the record.

- 2. The petitioners have availed an Over Draft Facility for Rs.2.5crores and a project loan for Rs.7crores, both on 10.06.2015, from the respondent Bank. The petitioners have now assailed the Exts.P2 to P4 notices.
- 3. The petitioner's counsel has submitted that the petitioners, despite their best efforts, could not repay the loans because of their financial difficulties. The petitioners thus want this Court to direct the respondent Bank to receive from the petitioners the outstanding loan amount in instalments.
- 4. Before proceeding any more, I may observe that expansive as the Court's jurisdiction of Article 226 of the Constitution of India is; it does not, I am afraid, go to the extent of interdicting the contractual terms, especially in a financial transaction involving public money, and compelling the respondent Bank to agree for instalments.
- 5. But the delays and difficulties in coercive process of recovery well known, the Bank's counsel, on instructions, has submitted that the bank has declared the petitioners loan as NPA and recalled them. Now the Bank is willing to regularise the loan accounts, if the petitioners deposit  $1/4^{\text{th}}$  of the overdue amount within a period of 30 days and the balance amounts in two equal monthly instalments thereafter, along with regular instalments.

6. So based on the Bank's concession, this Court disposes of

the writ petition, directing the petitioners to pay 1/4<sup>th</sup> of the

overdue amount in 30 days from the date of receipt of a certified

copy of this judgment and the balance in two equal monthly

instalments from then onwards. The petitioners have to pay the

loans including the amounts that have approved in the meanwhile

and other incidental expenditures the Bank may communicate to the

petitioners. On the petitioners paying these amounts as agreed,

in three months, then the Bank will regularise the loan account.

On the other hand, if the petitioners fail to pay any single

instalment within the stipulated time, the respondent Bank can

proceed without recourse to this Court.
