i. To issue a Writ in the nature of mandamus or any other appropriate writ, order or direction commanding the respondents to consider and take appropriate decision over Ext P3 representation with in time stipulated by this Hon'ble Court.

ii. To pass such other orders or directed that is deemed just and proper by this Hon'ble Court.

2. Heard the learned counsel for the petitioner and the learned Government Pleader appearing for the respondent.

3. It is submitted by the learned counsel for the petitioner that the term of the lease of the petitioner expires on 31.08.2018 and that the respondents may be directed to consider Ext.P3 representation preferred by the petitioner for continuing the lease agreements.

There will be a direction to the 1st respondent to take up, consider and pass orders on Ext.P3 representation preferred by the petitioner in accordance with law. Orders shall be passed within a period of six weeks from the date of receipt of a copy of this judgment.
