JUDGMENT

These writ petitions concern the alleged resignation of Smt.Manju, the petitioner in W.P.(C) No.29030 of 2017 from the post of H.S.A in C.V.K.M.H.S.S, East Kallada. Smt.Manju filed W.P.(C) No.29030 of 2017 seeking a direction permitting her to continue in service and also for payment of salary from 01.06.2017. According to the her, she had not resigned from the employment and further she stated that she withdrew the resignation before approval. The Manager filed W.P.(C) No.36213 of 2017 aggrieved by Ext.27 order passed by the District Educational Officer directing the Manager to permit Smt.Manju to continue her employment. This order was purportedly passed based on the directions issued by this Court in W.P.(C) No.29030 of 2017.

2. Smt.Manju has a case that she had never withdrawn from her resignation. According to the Manager, Smt.Manju

had executed resignation letter voluntarily in the backdrop of the allegations against her.

3. Anyhow, Rule 43 of Chapter XIVA KER insists for approval of resignation by the Educational Officer. If that be so, the matter can be easily concluded by the District Educational Officer after hearing Smt.Manju as well as the Manager.

Therefore, the District Educational Officer, Kollam is directed to take a decision in the matter within a period of one month, after hearing the petitioners. It is made clear that all the claims of Smt.Manju would depend upon the outcome of such decision.

These writ petitions are disposed of as above.
