JUDGMENT

The petitioner makes a very curious prayer in this writ petition. He says that the office belonging to the Kerala State Electricity Board Ltd (KSEB for short), now functioning in the 4th respondent's building, be not allowed to be shifted. Various reasons are stated in this writ petition for making this prayer, however, pertinently, there is nothing to show that the 4th respondent has authorised the petitioner to file this writ petition or that he wants the office of the KSEB to continue in his building.

2. Further, the learned Standing Counsel for the KSEB submits that the shifting of the office has been done so as to obtain a better building and that the present building, owned by the 4th respondent, is not suitable for their office, since the building does not have proper facilities.

In the afore circumstances, I see no reason

to maintain a writ petition of this nature and therefore, I dismiss it without passing any further orders.
