This writ petition is filed by an autorickshaw driver. The matter is related to parking of autorickshaws in city limits. The similar matter gained attention of the State Transport Appellate Tribunal, Ernakulam, noting that the Government notification does not applicable to Thrissur District and ordered that permits shall be granted without such restrictions. The judgment of the State Transport Appellate Tribunal, Ernakulam is produced as Ext.P3. The said judgment had also got approval in Exts.P4 judgment of this Court.

In the light of the above judgments, the respondents are directed to give permit to the petitioner as applied for in tune with Ext.P3 judgment of the State Transport Appellate Tribunal, Ernakulam within a period of one month from the date of receipt of a copy of this judgment.
