No. 121 of 2018 on the file of the VIII Additional Sessions Judge, Ranga Reddy District.

The petition coming on for hearing, upon perusing the Petition and the grounds filed herein, and upon hearing the arguments of Sri T. Ravi Kumar, Advocate for the Petitioner, and of Public Prosecutor(TG) for Respondent No.2, the Court made the following.

ORDER:

This petition is filed under Section 482 of the Code of Criminal Procedure, 1973, seeking for modification of the order dated 06-02-2018 in Criminal M.P.No. 20 of 2018 in Criminal Appeal No. 121 of 2018 on the file of the Court of VIII Additional Sessions Judge, Ranga Reddy District (for short, 'the Court below'), which is to the effect that the petitioner has to deposit Rs.4,00,000/- from out of the compensation amount of Rs.20,00,000/-.

2. The above order is passed while suspending the sentence imposed against the petitioner. Learned counsel for the petitioner now seeks for reduction of the said mount on the ground that the petitioner has a good case to succeed in the appeal and that the said condition is onerous.

3. Hence, considering the above, the condition imposed by the Court below is modified to the effect, that the petitioner shall deposit Rs.3,00,000/- instead of Rs.4,00,000/- and the time for such deposit is extended till 28-03-2018.

4. Subject to the above, the criminal petition is allowed. Pending miscellaneous petitions if any shall stand closed in consequence.
