Petition under Section 437/439 of Cr. P.C, praying that in the circumstances stated in the affidavit filed herein, the High Court may be pleased to grant regular bail to the petitioner /Accused No.2 in crime No.32/2018 of II Town Police Station Visakhapatnam.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed herein and upon hearing the arguments of KILARU NITHIN KRISHNA, Advocate for the Petitioner and of Public Prosecutor (AP) for the Respondent, the Court made the following.

**ORDER:**

This Criminal Petition, under Sections 437 and 439 of the Code of Criminal Procedure, 1973, is filed by the petitioner/A.2, for grant of bail in Crime No.32 of 2018 of II Town Police Station, Visakhapatnam city, registered for the offences punishable under Sections 186, 224, 354, 353, 506, 509 and 120-B of I.P.C.

2. Heard the learned counsel for the petitioner/A.2 and the learned Additional Public Prosecutor representing the respondent-State and perused the record.

3. During the course of submissions, it is brought to the notice of this Court that the petitioner is mentally unstable. The petitioner was remanded to judicial custody on 13.02.2018. Most part of the investigation is completed.

4. In view of the circumstances, the petitioner/A.2 is ordered to be released on bail on his executing personal bond for a sum of Rs.10,000/- (Rupees ten

thousand only) with two sureties in a like sum each to the satisfaction of the I  
Additional Chief Metropolitan Magistrate, Visakhapatnam.

5. The Criminal Petition is, accordingly, allowed.

Miscellaneous petitions, if any, pending in this Criminal Petition, shall  
stand closed.
