The report submitted by the police officer is perfunctory and leaves much to be desired. He does not appear even to have undertaken the exercise of ascertaining from the concerned Sub-Registrar whether the marriage registration certificate, enclosed along with the writ petition, is valid or not. Yet he states, in his report, that, if the petitioners satisfy him of their having married, he would then cause further inquiry. He further states that it is for the petitioners to establish that they are married.

With regards the police complaint submitted that the girl (petitioner no. 1) was missing, it is stated that the complaint was registered in Laksar Police Station apprehending that the girl had been abducted.

As we had recorded the presence of both the petitioners in the Court during the earlier hearing, we consider it appropriate to dispose of the writ petition permitting the petitioners to appear before the Laksar Police Station, and to inform the authorities concerned that the petitioner no. 1 has not been abducted by the second petitioner, and that both of them are happily married.

After satisfying himself that petitioner no. 1 has not been abducted by petitioner no. 2, and she has willingly and voluntarily married him, the third respondent shall take action forthwith, to close the complaint of the missing girl.

The writ petition stands disposed of accordingly.
