This writ petition has been filed to seek emergent parole under Rule 9 of the Rajasthan Prisoners (Released on Parole) Rules, 1958 (for short " the Rules of 1958").

The emergent parole has been sought on the ground of death of petitioner's father on 13<sup>th</sup> December, 2018. The petitioner wants to attend 12<sup>th</sup> day's rituals scheduled on 25<sup>th</sup> December, 2018.

The fact about the death of petitioner's father has been verified by the opposite side.

Learned Public Prosecutor Mr. Alladin Khan has contested the petition but could not give any reason to deny the parole.

In view of the above, criminal writ petition is allowed and the petitioner is released on emergent parole for a period of seven days under Rule 10A of the Rules of 1958.

The Superintendent, Central Jail, Sewar, Bharatpur is directed to release the petitioner, namely Radheyshyam S/o Late Shri Subesingh on parole for a period of seven days from the date of his release on furnishing his personal bond of Rs. 50,000/- (Rs. Fifty Thousand Only) with one surety in the like amount to the satisfaction of the Superintendent, Central Jail, Sewar, Bharatpur with the stipulation that he shall surrender himself and return back to the Central Jail, Sewar, Bharatpur. He shall maintain peace and tranquility during the period of parole which will include journey period also. In case, he fails to surrender on the stipulated date, the jail authority shall proceed in accordance with law.
