Notwithstanding the fact that recruitment of Judicial Officers to Subordinate Courts is governed by Chapter-VI of the Constitution of India and recruitment to service under the Union and States is as per Part-XVI Chapter-I and thus, no parity can be claimed with respect to the Service Rules pertaining to recruitment under the State in respect of recruitment to Judicial Officers in Subordinate Courts, but since the High Court is actively pursuing the matter of enhancing the upper age limit to 40 years as eligibility to take the Rajasthan Judicial Service Examination, Counsel for the petitioners seek leave to withdraw the writ petitions but with right reserved to re-approach the Court should the recommendations of the High Court be not accepted by the Government.

2. The writ petitions are dismissed as not pressed.
