Learned District & Sessions Judge, South Sikkim at Namchi, has sent a letter bearing Memo No. 34/D&SJ/(S) dated 29.05.2019, wherein he has forwarded a certified copy of the Order dated 20.05.2019, passed by the learned Judicial Magistrate, Jorethang Sub-Division, South Sikkim at Jorethang and the order dated 29.05.2019 passed by him in *General Register Case No. 03 of 2019 : State vs. Karma Dorjee Sherpa*, expressing the difficulty of the learned Judicial Magistrate to proceed with the matter.

Copy of this Order be sent to the learned Sessions Judge, South Sikkim at Namchi, learned Judicial Magistrate, Jorethang Sub-Division, South Sikkim at Jorethang as well as to the learned Judicial Magistrate, South Sikkim at Namchi, forthwith.

**6.** This Suo Motu Transfer Petition is, accordingly, disposed of.
