ORDER

- [1] Heard Mr. BR. Sharma, learned counsel appearing for the petitioner and Mr. Athouba, learned G.A. appearing for the respondents.
- [2] Prayer in the writ petition reads as follows:
 - "(i) Allow the petitioner a similar relief granted by this Hon'ble Court in various writ petitions including W.P.(C) No. 517 of 2010 along with 5 other writ petitions at Annexure A/4 and W.P.(C) No. 254 of 2011 with other 11 writ petitions at Annexure A/5 and also as allowed by this Hon'ble Court in the Review Petition No. 11 of 2013, at Annexure A/6 by directing the respondents to allow the petitioner to enjoy/get the benefit of the enhanced Ex-gratia amount of Rs. 1,00,000/- (Rupees one lakh) only as enhanced by the Government of Manipur by an order dated 6th August, 1998 at Annexure A/3 by paying the petitioner an additional amount of Rs. 50,000/- (Rupees fifty thousand) only for the death of her son over and above the Rs. 50,000/- (Rupees fifty thousand) only paid earlier for the deceased at the earlier rate of ex-gratia."

[3] Notice was issued on 21.11.2014. State respondents accepted notice on behalf of the respondents.

In this case, petitioner is claiming for enhancement of payment of ex-gratia to the death of her husband namely, (L) Pastor Gentinlam from the ethnic clash happened on 25.03.1998. The petitioner pleads that as per order (Annexure - A/1) dated 08.02.1999, the petitioner has received a sum of Rs. 50,000/- (Rupees fifty thousand) only as ex-gratia amount. Subsequently, vide order (Annexure -A/3) dated 06.08.1998, the ex-gratia amount was modified as Rs. 1,00,000/- (Rupees one lakh) only. The petitioner relies upon decisions of this Court (Annexure - A/4) dated 30.08.2010 and (Annexure - A/5) dated 26.07.2011 for payment of ex-gratia. However, the petitioner has not made any request in this regard.

In this view of the matter, writ petition is disposed of by giving liberty to make a detailed representation to the authority concerned for enhanced payment of ex-gratia amount along with supportive various documents and judicial orders within a period of 4 (four) weeks from the date of receipt of a copy of this order and the authority will consider and dispose of the representation within a period of 8-12 weeks on its own merits.

[6] Writ petition is disposed of as above.
