- 1. The petitioner has approached this Court for initiating action under Section 12 of the Contempt of Court's Act, 1971 read Article 215 of the Constitution of India and Rule 9 of the Contempt Courts (High Court of Meghalaya) Rules, 2013 seeking directions for punishment to the respondents for wilful disobedience of the judgment and order dated 31.10.2018 passed in Cont. Cas (C) No. 18 of 2018 arising out of WP(C) No. 371 of 2017.
- 2. The contempt petition came up for hearing on 15.07.2019 and the following order was passed;

"Learned counsel for the respondents has produced a copy of the PPO issued by the Office of Accountant General (A&E), Meghalaya, Shillong to the Superintendent of Police, East Garo Hills District, Williamnagar and the same is taken on record.

Learned counsel for the respondents submitted that a cheque for the amount due which is payable to the petitioner will be either produced in the Court or payment will be made to the petitioner before the next date. Accordingly, the matter is adjourned to 30.07.2019."

3. Learned State counsel has produced a letter No. RE/EGH/V-1/22-2014-19/27 dated 25.07.2019 addressed by the Superintendent of Police, East Garo Hills, Williamnagar to the Assistant Inspector General of Police (E), Meghalaya, Shillong wherein, it has been intimated that the UBSI. Sujit Bhattacharjee who was deputed to assist the petitioner and after completing

all the formalities in the matter, the monthly pension benefit amounting to a total sum of ₹ 4,85,021/- (Rupees four lakhs eighty five thousand and twenty one) from the month of January 2017 to June 2019 has been credited to the SBI account of Smt. Rayal Dorjee through her Account No. 37128182540 as per the Pensioner's Payment slip. The said communication is taken on record.

4. In view of the above, learned counsel for the petitioner submitted that the contempt petition has been rendered infructuous and may be disposed of as such. Ordered accordingly.
