ORDER

Heard Mr. S. Kanungoe, learned counsel for the petitioners. Also heard Mr. S. S. Roy, learned Government Advocate, Assam.

The only plea raised in this petition is that though the petitioners along with other colleagues had approached this Court in the year 2010 for appointment to the posts of Constable by filing a writ petition, at the time of filing of the writ petition because of some mistakes, their names were not included in the list of the petitioners. It has been submitted that the said writ petition being WP(C) No.2725 of 2010 was disposed of by this Court on 22.02.2019 granting amongst others, the following reliefs:

- "(1) The respondents are directed to consider the case of the petitioners for their appointment to the post of Armed Branch Constable or in any other equivalent post in the vacancies available i.e. current and next available vacancies. If the vacancies are limited, the petitioners will be considered in a phase manner till all of them are considered. (2) If it is found that the petitioners in the meantime have become overaged, the respondent authorities shall give them age relaxation as may be required. (3) It is made clear that the respondents without considering the case of the petitioners shall not fill up any post of Armed Branch Constable."
- 3) It has been submitted by the learned counsel for the petitioners that because of the omission of the names of the petitioners from the said petition, the petitioners have not been granted the aforesaid relief. The petitioners submit that they are otherwise similarly situated along with all these petitioners in WP(C) No.2725/2010.
- 4) In that view of the matter, the present petition is disposed of with the direction to the respondent authorities to consider the plea of the petitioners for grant of similar benefits, if they are found to be similarly situated as those petitioners in WP (C) No.2725/2010 by issuing a speaking order within a period of 1 (one) month from the date of receipt of a certified copy of this order.
