Heard Mr. A Deka, learned counsel for the petitioner. Also heard Mr. N Sarma, learned Standing Counsel, Education (Secondary) Department, Government of Assam for the State respondents.

The matter pertains to claim for provicialisation of service of the petitioner who is working as a Craft Teacher in Khaliha High School.

It has been submitted that though after enactment of the Assam Venture Educational Institutions (Provincialisation of Services) Act, 2011, the respondent authorities were in the process of considering the case of the petitioner for provincialisation, the said process could not be concluded as the said Act was struck down as *ultra vires* by this Court on 23.9.2016. Subsequently, the State Government has enacted the Assam Education (Provincialisation of Service of Teachers and Re-organization of Educational Institutions) Act, 2017. Accordingly, it has been submitted that the concerned authority may be directed to consider the claim of the petitioner for provincialisation afresh as per the 2017 Act.

After hearing the learned counsel for the parties and on perusal of the materials on record, this writ petition is disposed of with a direction to the respondent authorities to consider the claim of the petitioner for provincialisation under the new Act i.e. the 2017 Act and if found to be eligible, necessary orders be passed in this regard.

The entire exercise as directed shall be undertaken within a period of six months from the date of receipt of a certified copy of this order.

Till appropriate orders are passed with regard to the claim of the petitioner for provincialisation, the post held by the petitioner as Craft Teacher in Khaliha High School shall not be filled up by any other person.

The writ petition stands disposed of accordingly.
