Heard Mr. S.K. Taukdar, learned counsel for the petitioners as well as Mr. N. Sarma, learned Standing Counsel for the Elementary Education Department.

By this writ petition, the petitioner assails the letter dated 28.10.2014, by which the DEEO, Karimganj has instructed the BEEO, South Karimganj for constituting a new School Managing Committee of the petitioner.

As the writ petition was filed in the year 2014 and the term of a School Managing Committee is only for a period of 3 (three) years, the term of the School Managing Committee should have expired as on date.

In view of the above reason, this Court finds that the present writ petition has become infructuous.

Writ petition is accordingly dismissed as infructuous.
